TRADEMARK TERMINATION AND RELEASE

THIS TRADEMARK PROPERTY TERMINATION AND RELEASE (this "Agreement") dated as of July 29, 2005, is made by and among MediMedia USA, Inc., a Delaware corporation (the "Company"), each of the Company's subsidiaries and affiliates specified on the signature pages hereof (such subsidiaries, together with the Company, collectively, the "Grantors" and each a "Grantor"), and The Governor and Company of the Bank of Scotland, as security agent (in such capacity, the "Agent"). Capitalized terms used herein, but otherwise not defined, shall have the meanings ascribed to them in the Credit Facilities (as defined below).

RECITALS

A. WHEREAS, the Grantors and the Agent are parties to that certain Facilities Agreement, dated as of April 17, 2002 (as amended, restated, supplemented or otherwise modified to the date hereof, the "Existing Credit Agreement"), by and among Santémedia Group Holding S.à.r.l. as Parent "Holdings", certain subsidiaries of Holdings (including the Grantors) and the Agent.

B. WHEREAS, each Grantor granted a security interest in the trademarks identified on Exhibit A attached hereto (collectively, the "Trademarks") to the Agent, pursuant to certain collateral security documents entered into in connection with the Existing Credit Agreement (such security documents, as they may be amended, restated, supplemented or otherwise modified to the date hereof, the "Existing Security Agreements" and each, an "Existing Security Agreement"), executed by such Grantor and others in favor of the Agent.

C. WHEREAS, in order to evidence the grant of security interests under the Existing Security Agreements, each Grantor caused the due execution and delivery of certain filings in the United States Patent and Trademark Office (the "USPTO").

D. WHEREAS, the Grantors and the Agent have entered into that certain letter agreement dated as of July 29, 2005 (the "Payoff and Release Letter") whereby they have terminated their respective obligations under the Existing Credit Agreement, the other loan documents and all documents and agreements delivered pursuant to or in connection with the Existing Credit Agreement to the extent described therein.

F. WHEREAS, the Agent has agreed to terminate and release all security interests granted to or held by the Agent as security for the obligations under the Existing Credit Agreement and the other loan documents.

G. WHEREAS, in order to evidence the release of the security interests granted pursuant to each of the Existing Security Agreements, Holdings and the Grantors have requested that the Agent execute and deliver this Agreement and the Agent has agreed to execute and deliver this Agreement.

NOW THEREFORE, with intent to be legally bound hereby and for other good and valuable consideration, receipt of which is hereby acknowledged, the Grantors and the Agent hereby agree as follows:

SECTION 1. Release and Discharge. In furtherance of the releases granted pursuant to the Payoff and Release Letter, the Agent agrees to terminate and release all security interests granted to or held by the Agent in the Trademarks pursuant to the applicable Existing Security Agreement as security for the obligations under the Existing Credit Agreement and the other loan documents. The Agent agrees that the Trademarks securing the obligations are hereby released and discharged (without recourse, representation or warranty) from the security interests granted pursuant to the applicable Existing Security Agreement and such security interests are hereby reconveyed to the applicable Grantor.

SECTION 2. Effectiveness. This Agreement becomes effective when (i) all parties hereto have executed and delivered a counterpart hereof (including by way of facsimile transmission) and (ii) the Payoff and Release Letter has become effective.

SECTION 3. Further Assurances. The Agent agrees that it shall, from time to time, at the expense of the applicable Grantor, execute, acknowledge and deliver to the applicable Grantor and its designees, successors or assigns such instruments, agreements, and other documents as the applicable Grantor or its successors or assigns shall reasonably request in order to further evidence the releases and discharges described in Section 1 above.

SECTION 4. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of New York without giving effect to the conflict of laws principles thereof.

SECTION 5. Counterparts. This Agreement may be executed in any number of counterparts (including by facsimile transmission), each of which shall be an original, but all of which, taken together, shall constitute one and the same document.


