TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignors hereby assign, transfer, convey and deliver to the Assignee, its successors and assigns, effective as of the date first referred above, all right, title, and interest of the Assignors in and to:

the Trademarks listed in Exhibit A;

all registrations and pending applications to register or otherwise obtain legal protection, domestic and foreign, for any of the foregoing;

all rights to make application, domestic and foreign, in the future to register or otherwise obtain legal protection for any of the foregoing;

all rights of priority under national laws, domestic and foreign, and international conventions with respect to any of the foregoing;

all income, royalties, damages, and payments now or hereafter due or payable in respect thereto;

all goodwill of the business associated with the Trademarks;

all causes of action (either in law or equity), and the right to sue, counterclaim, and recover for past, present, and future infringement, misappropriation, or dilution thereof of any of the foregoing; and

all other rights and privileges corresponding thereto throughout the world;

the same to be held and enjoyed by the Assignee for its own use and enjoyment and for the use and enjoyment of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignors if this assignment and sale had not been made.

The Assignors further agree, without further consideration, to execute and deliver, or arrange for the delivery of, such further documents and instruments as the Assignee may reasonably request, to effectuate and record this Assignment and the assignment of the Trademarks and any other intellectual property rights purported to be transferred hereunder, including execution of assignments in recordable form in each jurisdiction where registrations or applications for the Trademarks may be issued or pending and to take the steps necessary to put in the name of Assignee all of the Trademarks being transferred hereunder.

With reasonable notice to Assignee, Assignor has a right to buy back from Assignee the Trademarks listed in Exhibit A for a sum that shall not exceed

Assignee or its designee will perform the functions of renewing and maintaining the Trademarks listed in Exhibit A.
