## REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest (this "*Release*") is made as of April 27, 2015 by each of the signatories listed below (each a "*Secured Party*" and, together, the "*Secured Parties*") to and in favor of Apriva, LLC, an Arizona limited liability company, with its principal place of business at 8501 North Scottsdale Road, Suite 110, Scottsdale, AZ 85253 ("*Company*").

### Recitals

WHEREAS, Company granted to the Secured Parties a security interest in certain interests of the Company in the patents, and trademarks listed on Exhibit A and Exhibit B attached hereto (respectively, the "*Patents*" and the "*Trademarks*"), under an Intellectual Property Security Agreement dated as of November 11, 2009 (the "*Security Agreement*").

WHEREAS, Secured Party's security interest in the Patents granted pursuant to the Security Agreement was recorded with the U.S. Patent and Trademark Office ("*PTO*") on November 19, 2009 at Reel Number 023538 and Frame Number 0566.

WHEREAS, Secured Party's security interest in the Trademarks granted pursuant to the Security Agreement was recorded with the PTO on November 19, 2009 at Reel Number 4099 and Frame Number 0582.

WHEREAS, the Company has satisfied all its obligations to Secured Parties with respect to the loan documents entered into in connection with the Security Agreement (the "*2009 Loan Documents*"), there are no obligations owing to the Secured Parties under the 2009 Loan Documents that are secured by a security interest in any of the Patents or Trademarks pursuant to the Security Agreement, and the Secured Parties wish to reassign to the Company all interest granted by the Company in the Patents and Trademarks to the Secured Parties under the Security Agreement or any of the 2009 Loan Documents.

### Agreement

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Secured Party hereby unconditionally releases and terminates its security interest in the Patents and Trademarks as set forth on November 19, 2009 at Reel Number 023538 and Frame Number 0566 or November 19, 2009 at Reel Number 4099 and Frame Number 0582, as applicable.

Secured Party further authorizes and requests that the Commissioners of Patents and Trademarks and any other government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of Arizona.


