**OMNIBUS BILL OF SALE AND
ASSIGNMENT IN COMPLETE LIQUIDATION
(US SEARCH LLC)**

THIS OMNIBUS BILL OF SALE AND ASSIGNMENT IN COMPLETE LIQUIDATION (this "*Assignment*") is made and entered into by and between US SEARCH LLC, a Delaware limited liability company (the "*Company*") and US SEARCH, INC., a Delaware corporation (the "*Member*")

RECITALS

A. A Plan of Complete Liquidation and Dissolution for the Company has been adopted by the Member of the Company (the "*Plan*").

B. In furtherance of the Plan, this instrument is intended to effect the distribution to the Member, in complete liquidation of the Company and in redemption and cancellation of all of its issued and outstanding membership interests, all properties, claims, rights and interests of the Company, whether known or unknown, fixed or contingent, real or personal, subject to unpaid liabilities of the Company (the "*Assets*").

C. Member is the sole owner and holds all of the membership interests of the Company (the "*Interests*").

D. The Assets of the Company will be distributed to the Member in liquidation of the Company.

E. Terms used in this instrument and not otherwise defined shall have the meaning ascribed to such term in the Plan.

THEREFORE, in consummation of the Plan and in accordance with Section 332 of the Code, effective as of 11:59 pm, August 30, 2013:

1. The Company hereby assigns, transfers, conveys and distributes the Assets to the Member, in redemption and cancellation of the Interests and in complete liquidation of the Company pursuant to the Plan.

2. Member hereby transfers and conveys to the Company the Interests in complete redemption and cancellation of the Interests.

3. This Assignment is in addition to such additional instruments of assignment as may be given to document the transfer of Assets of the Company to the Member.

4. This Assignment may be signed in counterparts, each of which shall be deemed an original and all of which shall constitute one and the same instrument.




