DECLARATION OF LUKE YEH

On November 20, 2014, Snapchat, Inc. ("Snapchat"), on advice of its former U.S. trademark counsel, filed a request with the Assignment Division of the United States Patent and Trademark Office ("USPTO") to record a document (the "Document") purporting to assign title of U.S. trademark Application Serial No. 85/598,614 for the mark SNAPCASH in Classes 9, 36 and 42 (the "Application") from Mitek Systems, Inc. ("Mitek") to Snapchat. The Assignment Division recorded the Document at **Reel 5405 and Frame 0515**. Snapchat is currently identified in the USPTO's Trademark Status & Document Retrieval System as the current owner of the Application.

Based on facts that became known to Snapchat subsequent to the recordal, the Document did not actually transfer ownership of the Application to Snapchat. Accordingly, Mitek has been and continues to be the owner of the Application. In view of the foregoing, Snapchat respectfully requests that the records of the USPTO be corrected to reflect Mitek as the current owner and to reflect that Snapchat never owned any interest in the Application.
