**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the “Release”) is made effective as of April 24, 2015, by JPMORGAN CHASE BANK, N.A., as Administrative Agent (the “Administrative Agent”) to RBC SOUTHWEST PRODUCTS, INC. (the “Grantor”) as follows:

WHEREAS, on November 30, 2010, Roller Bearing Company of America, Inc. (“Borrower”), RBC Bearings Incorporated (“Holdings”), the Grantor, certain corporate subsidiaries of Holdings and the Administrative Agent entered into a Security Agreement (as from time to time amended, restated, supplemented or otherwise modified, the “Security Agreement”) and the Grantor and the Administrative Agent entered into a Trademark Security Agreement (the “Trademark Agreement”);

WHEREAS, pursuant to the Security Agreement and the Trademark Agreement, the Grantor granted to the Administrative Agent, among other collateral, a continuing security interest in all of such Grantor’s right, title and interest in, to, and under the United States Trademarks listed on the attached Schedule A (the “Trademarks”);


WHEREAS, the Trademark Agreement was recorded in the United States Patent and Trademark Office on November 30, 2010 at reel/frame 4422/972; and
