**Trademark Assignment**

This Trademark Assignment (“Assignment”) is made effective as of April 1, 2015 (“Effective Date”) by and between Gabriel Marquez, an individual with a principal place of business at 811 State Street, Suite G, Santa Barbara, California 93101 (“ASSIGNOR”), and Firestone Walker LLC, a California limited liability company, with a principal place of business at 1400 Ramada Dr., Paso Robles, CA 93446 (“ASSIGNEE”).

WHEREAS, ASSIGNOR is the owner of the Trademark 805 which was registered in the United States Patent and Trademark Office on June 13, 2006 as Reg. No. 3102926 (“Trademark”), together with common law rights therein; and

WHEREAS, ASSIGNOR desires to transfer, assign, and quitclaim to ASSIGNEE all of its right, title, and interest in and to the Trademark together with all common law rights therein;


NOW THEREFORE, for good and valuable consideration, including the provisions and covenants herein, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR and ASSIGNEE agree as follows:

1. ASSIGNOR hereby sells, transfers, assigns, and quitclaims to ASSIGNEE, as of the Effective Date, all of ASSIGNOR’s right, title, and interest of whatever kind in and to the Trademark in perpetuity, together with (1) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Trademark, if any, including without limitation, damages, and payments for infringements and misappropriations of the Trademark after the Effective Date; (2) all rights to sue for infringements or misappropriations of the Trademark after the Effective Date; and (3) the right to file, renew, and maintain any trademark applications or registrations related to the Trademark.

2. ASSIGNOR hereby agrees to execute such other documents and take such other actions as may be reasonably requested by ASSIGNEE to evidence more fully the transfer of ownership of the Trademark to ASSIGNEE. ASSIGNOR hereby appoints ASSIGNEE, with the full power of substitution therein, as its true and lawful attorney-in-fact for the limited purpose of executing such papers and performing such other proper acts as are reasonably necessary to secure to ASSIGNEE, or to its successors or assigns, the rights hereby transferred.
