And the Assignee hereby acknowledges that all of the Assignor's rights to the Marks and the Registrations are being conveyed by the Assignor to the Assignee strictly "AS IS", with all defects, and with no express or implied representations or warranties.

This Assignment shall be governed by and shall be construed in accordance with the laws of the State of Hawaii and the United States of America. Any and all disputes between Assignor and Assignee arising out of, or relating to, this Assignment shall be finally resolved pursuant to the dispute resolution provisions of that certain Asset Purchase Agreement between Assignor and Assignee dated March 24, 2015.
