RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of April 27, 2015 by SQUARE 1 BANK (the "Bank"). Reference is hereby made to (a) that certain Second Loan and Security Agreement dated as of January 30, 2013 (the "Loan Agreement"), among UNIVA CORPORATION, a Delaware corporation ("Grantor"), as borrower, and the Bank, as lender, and (b) that certain Second Intellectual Property Security Agreement, dated as of January 30, 2013, between Grantor and the Bank (the "IP Security Agreement"). Terms used but not defined in this Release shall have the meanings given thereto in the Credit Agreement and/or the IP Security Agreement, as applicable.

WHEREAS, pursuant to the IP Security Agreement, the Bank was granted a security interest in and to the Collateral, including the Trademarks listed in Schedule A (the "Trademark Collateral");

WHEREAS, Grantor has requested that the Bank terminate and release its security interests in and to the Trademark Collateral and execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office ("USPTO"); and

WHEREAS, the Bank has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Bank hereby:

1. Releases and terminates all security interests and other interests, rights, privileges and remedies it may have in the Trademark Collateral;
2. Reassigns to the Grantor any and all liens, security interests, right, title and interest granted to the Bank in the Trademark Collateral; and
3. Authorizes the Grantor (or its designee) to file this Release with the USPTO and any other governmental authority.


