VHA-UHC Alliance NewCo Inc. (the “**Corporation**”), a corporation organized and existing under the General Corporation Law of the State of Delaware, hereby certifies as follows:

1. This Certificate of Amendment (the “**Certificate of Amendment**”) amends the provisions of the Corporation’s Amended and Restated Certificate of Incorporation filed with the Secretary of State on March 20, 2015 (the “**Certificate of Incorporation**”).

2. Article One of the Certificate of Incorporation is hereby amended and restated in its entirety as follows:
