RELEASE OF TRADEMARK SECURITY AGREEMENT

RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of April 24, 2015 (this "Agreement"), by BANK OF AMERICA, N.A., as collateral agent (together with its successors in such capacity, the "Collateral Agent") for each of the Secured Parties, pursuant to the Credit Agreement referred to below.

WITNESSETH:

WHEREAS, the Collateral Agent, GOLDEN STATE MEDICAL SUPPLY, INC., a California corporation (the "Grantor") BLENHEIM PHARMACAL, INC., a New York corporation and GSMS, INC., a Texas corporation and BPI PHARMACAL LLC, a New York limited liability company are, among others, parties to a certain Credit Agreement dated as of October 29, 2014 (as amended, supplemented, amended and restated or otherwise modifies from time to time, the "Credit Agreement"); and

WHEREAS, in connection with the Credit Agreement, the Grantor and certain other grantors executed a Pledge and Security Agreement, dated as of October 29, 2014 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Security Agreement") pursuant to which Grantor was required to execute a Trademark Security Agreement and granted to Collateral Agent a continuing security interest in the trademark collateral listed on Schedule A attached hereto (collectively, the "Trademark Collateral"); and

WHEREAS, the Secured Obligations (as defined in the Security Agreement) have been fully satisfied and, therefore, the Grantor has requested, and the Collateral Agent has agreed, that the Collateral Agent release its security interest in the Trademark Collateral and reassign the same to Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- (1) The Collateral Agent hereby releases its security interest in the Collateral Agent's rights, title and interest in and to the Trademark Collateral, as such rights, title and interest are granted in the Trademark Security Agreement.
- (2) The Collateral Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by the Collateral Agent, all of the Collateral Agent's rights, title and interest in and to the Trademark Collateral, as such rights, title and interest are granted in the Trademark Security Agreement.
- (3) This Agreement may be executed in any number of counterparts, each of which when executed and telecopied signatures (or signatures delivered via electronic mail or "pdf") will be deemed to be an original and all of which counterparts of this Agreement taken together will be deemed to be but one and the same instrument.

IN WITNESS WHEREOF, the Collateral Agent has caused this Agreement to be duly executed by its duly authorized officer as of the day and year first above written.

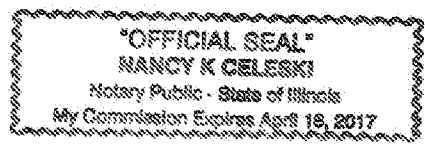
