## RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

This Release of Security Interests in Intellectual Property is made as of April 29, 2015 by KAYNE CREDIT OPPORTUNITIES FUND (QP), LP, as collateral agent for itself and all Purchasers party to the Note Purchase Agreement referred to below (the "Secured Party"), having an address at 655 Madison Avenue, 18<sup>th</sup> Floor, New York, New York, regarding NYLONCRAFT, INC., an Indiana corporation (the "Nyloncraft"), and Techniplas, LLC, a Delaware limited liability company (together with Nyloncraft, the "Companies") having an address at 616 W. McKinley Avenue, Mishawaka, Indiana 46545, and with reference to the following facts:

WHEREAS, the Companies, certain affiliates of the Companies (collectively the "Issuers"), the Secured Party and the Purchasers had previously entered into a Note Purchase Agreement dated as of May 13, 2014, as amended to date (as so amended, the "Note Purchase Agreement"), for the purpose of evidencing and securing certain obligations of the Issuers (as defined therein) to the Secured Party and the other Purchasers (as defined therein); and

WHEREAS, the Companies have granted the Secured Party a security interest in certain intellectual property of the Companies and have entered into that certain (i) Second Lien Notice of Security Interest in Intellectual Property, dated May 13, 2014, and recorded in the United States Patent and Trademark Office against the Trademarks set forth therein on May 13, 2014, at Reel 005279, Frame 0055, and against the Patents set forth therein on May 13, 2014, at Reel 32890, Frame 408, and (ii) Second Lien Notice of Security Interest in Intellectual Property, dated as May 13, 2014, and recorded against the Trademarks set forth therein on May 13, 2014, at Reel 005279, Frame 0020;

WHEREAS, the Secured Party desires to release its security interest in the personal property of the Companies which was granted to the Secured Party pursuant to the Security Agreement;

NOW, THEREFORE, for valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Secured Party releases any and all security interests held by it in and to any and all of the patents listed on Exhibit A attached hereto and in and to all proceeds and benefits thereof and the trademarks, service marks, applications therefore and associated goodwill therein, owned by the Companies, including without limitation the trademark application listed on Exhibit B attached hereto, and in and to all proceeds and benefits thereof.



