**TRADEMARK ASSIGNMENT AGREEMENT**

This Assignment ("Agreement") is made effective as of this March 31, 2015, by LGM HOLDINGS, Inc. ("Assignor"), a Pennsylvania corporation, in favor of Daniel Bacine, an individual ("Assignee").

WHEREAS Assignor has adopted and used, and continues to use the Mark and service marks identified on the attached Schedule A, which are registered with the US Patent and Trademark Office to the extent noted on Schedule A (hereinafter referred to as the "Mark").

WHEREAS: Assignor has entered into a certain Plan of Liquidation and Dissolution dated as of this March 31, 2015 pursuant to which Assignor will be dissolved and liquidated (the "Plan").

WHEREAS: Prior to the Plan and the contemplated sale of the Assignor's assets to META GLOBAL, LLC under that certain Asset Purchase Agreement dated as of the date hereof among META GLOBAL, LLC and Assignor (the "Purchase Agreement"), Assignor intends to assign the Mark to Assignee, with the knowledge and consent of the parties to the Purchase Agreement, and the plan is for Assignee to enter into a licensing agreement with META GLOBAL, LLC.


AND WHEREAS: in accordance with the Plan, it is desired that the assignment of said Trademarks contemplated by the Purchase Agreement be made of record in the United States Patent and Trademarks Office.

NOW, THEREFORE, pursuant to the Purchase Agreement, and, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign and transfer unto said Assignee, his executors, administrations, personal representatives, successors and assigns, all right, title and interest in and to said Mark, together with the goodwill of the business symbolized by said Mark, and the registrations thereof; and for aforesaid considerations Assignor hereby covenants, agrees and undertakes to execute whenever requested by Assignee, all applications, assignments, lawful oaths and any other documents that Assignee may reasonably deem necessary or desirable for securing or for maintaining the Mark hereby assigned or agreed to be assigned; all without further compensation to Assignor.


