RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

This Release of Security Interests in Trademarks is made as of April 29, 2015 by THE PRIVATEBANK AND TRUST COMPANY, as administrative agent for itself and all Lenders party to the Loan Agreement referred to below (the "Secured Party"), having an address at 120 South LaSalle Street, Suite 200, Chicago, Illinois, 60603, regarding NYLONCRAFT, INC., an Indiana corporation (the "Nyloncraft"), and Techniplas, LLC, a Delaware limited liability company (together with Nyloncraft, the "Companies"), having an address at 616 W. McKinley Avenue, Mishawaka, Indiana 46545, and with reference to the following facts:

WHEREAS, the Companies and certain affiliates of the Companies (collectively the "Borrowers"), the Secured Party and the Lenders had previously entered into an Amended and Restated Loan and Security Agreement dated as of May 12, 2014, as amended to date (as so amended, the "Loan Agreement"), for the purpose of evidencing and securing certain obligations of the Borrowers (as defined therein) to the Secured Party and the other Lenders (as defined therein);

WHEREAS, the Companies have granted the Administrative Agent a security interest in certain intellectual property of the Companies and have entered into that certain (i) Amended and Restated Notice of Security Interest in Intellectual Property, dated May 12, 2014, and recorded in the United States Patent and Trademark Office against the Trademarks set forth therein on May 12, 2014, at Reel 005278, Frame 0422, and against the Patents set forth therein on May 12, 2014, at Reel 32871, Frame 889; (ii) Notice of Security Interest in Intellectual Property, dated August 31, 2012, and recorded in the United States Patent and Trademark Office against the Trademarks set forth therein on October 2, 2012, at Reel 004870, Frame 0914 and against the Patents set forth therein at Reel 29065, Frame 970; (iii) Notice of Security Interest in Intellectual Property, dated August 31, 2012, and recorded in the United States Patent and Trademark Office against the Trademarks set forth therein on October 2, 2012, at Reel 004870, Frame 0973, and (iv) Trademark Security Agreement, dated April 16, 2010, and recorded in the United States Patent and Trademark Office against the Trademarks set forth therein on April 23, 2010, at Reel 004191, Frame 0288; and

WHEREAS, the Secured Party desires to release its security interest in the personal property of the Companies which was granted to the Secured Party pursuant to the Security Agreement;

NOW, THEREFORE, for valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Secured Party releases any and all security interests held by it in and to any and all of the patents listed on Exhibit A attached hereto and in and to all proceeds and benefits thereof and the trademarks,


service marks, applications therefore and associated goodwill therein, owned by the Company, including without limitation the trademark application listed on Exhibit B attached hereto, and in and to all proceeds and benefits thereof.



