Pursuant to sections 33-600 to 33-998 of the Connecticut General Statutes, inclusive, the domestic business corporation and the foreign business corporation herein named do hereby submit the following certificate of merger.

1. The names of the parties to the merger are **AAPER ALCOHOL AND CHEMICAL COMPANY** a corporation organized and existing under the laws of the State of Kentucky (hereinafter "**Aaper-KY**"), and **PHARMCO PRODUCTS, INC.**, a corporation organized and existing under the laws of the State of Connecticut (hereinafter "**Pharmco-CT**").

2. **Pharmco-CT** will continue its existence as the surviving corporation under the name "**PHARMCO PRODUCTS, INC.**" pursuant to sections 33-600 to 33-998, inclusive.

3. The effective date of the merger herein provided for shall be as of the end of the business day on December 31, 2012.

4. The Certificate of Incorporation of the surviving corporation at the effective date of the merger shall be the Certificate of Incorporation of said surviving corporation and said Certificate of Incorporation shall continue in full force and effect until further amended and changed in the manner prescribed by the provisions of the Connecticut Business Corporation Act.

5. The plan of merger was duly approved by the sole shareholder of **Aaper-KY** in the manner required by the law of the State of Kentucky, and by the certificate of incorporation of **Aaper-KY**.

6. The plan of merger was duly approved by the sole shareholder of **Pharmco-CT** in the manner required by sections 33-600 to 33-998 of the Connecticut General Statutes, inclusive, and the certificate of incorporation of **Pharmco-CT**.

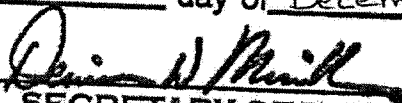
