TERMINATION OF TRADEMARK SECURITY INTEREST

WHEREAS, HEALTHX PARENT CORPORATION, a Delaware corporation ("*Parent*"), HEALTHX HOLDINGS, INC., a Delaware corporation ("*Holdings*"), and HEALTHX, INC., an Indiana corporation (collectively, the "*Grantors*") have entered into that certain Intellectual Property Security Agreement dated as of December 28, 2011, by and among ESCALATE CAPITAL PARTNERS SBIC I, L.P. (the "*Secured Party*") (the "*IP Security Agreement*"), a true and correct copy of which were recorded in the United States Patent and Trademark Office on January 11, 2012 at Reel 04696, Frame 0542;

1. releases and reassigns to the Grantors any and all liens, security interests, right, title and interest of the Secured Party in the trademarks and trademark applications more fully described on Exhibit A, without recourse or representation or warranty, express or implied; and
2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.
