## ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS (this "Assignment") is entered into and made effective as of November 7, 2014 (the "Effective Date") by and between Sheaffer Pen Corporation, a Delaware corporation with its principal place of business at One Bic Way, Suite 1, Shelton, Connecticut 06484 ("Assignor") and A.T.X. International, Inc., a Rhode Island corporation with its principal place of business at One Albion Road, Suite 200, Lincoln, Rhode Island 02865 ("Assignee") (each, a "Party" and together, the "Parties").

WHEREAS, Assignor is the owner of those certain trademarks and corresponding U.S. Trademark Registrations identified on Exhibit A attached hereto and made a part hereof (the "Assigned Marks"); and

WHEREAS, Assignee desires to obtain all rights in and to the Assigned Marks.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignor does hereby assign, convey, transfer and deliver to Assignee all right, title and interest in and to the Assigned Marks, together with the goodwill of the business symbolized by and associated with the Assigned Marks, the right to secure all renewals and extensions thereof, and the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in conjunction with, any and all past, present or future infringement or dilution of or damage or injury to the Assigned Marks or the accompanying goodwill.

2. Ownership. Assignor hereby acknowledges and agrees that from and after the Effective Date, Assignee shall be the exclusive owner of the Assigned Marks and associated goodwill.

3. Further Assurances. Assignor shall furnish all necessary documentation reasonably available to Assignor relating to or supporting chain of title, execute all appropriate papers, take all rightful oaths, and do all rightful acts which may be reasonably necessary for vesting title to, and effectuating the transfer and recording of, the Assigned Marks in Assignee, its successors, assigns, legal representatives or nominees.

4. Entire Agreement. This Assignment constitutes the entire agreement between the Parties with respect to the subject matter contained herein. Neither Party is relying upon and shall not rely upon any prior or contemporaneous written or oral promises or representations not expressly set forth herein.

5. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of New York, without resort to or application of the choice of law principles thereof.


