**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of April 30, 2015 (this "Release"), is made by Jefferies Finance LLC, as Collateral Agent ("Agent"), in favor of Genoa, a QoL Healthcare Company, LLC (f/k/a QoL meds, LLC), as successor in interest to Genoa Healthcare, LLC ("Grantor") as follows:

NOW, THEREFORE, the Agent, without representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any and right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.

The Agent agrees to provide Grantor with any information and additional authorization and documentation necessary to effect the release of the Agent's security interest in the Trademark Collateral (without recourse, representation or warranty and at Grantor's sole cost and expense).
