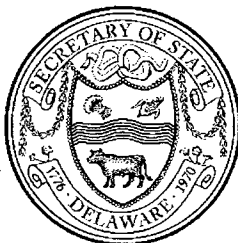

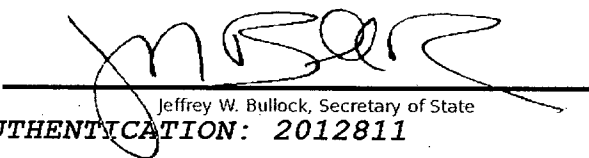

ABB Inc., a corporation incorporated on the 2nd day of June, 1988, pursuant to the provisions of the Delaware General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That this corporation owns more than 90% of the capital stock of Tropos Networks, Inc., a corporation incorporated on the 14th day of June, 2012 A.D., pursuant to the provisions of the Delaware General Corporation Law and that this corporation, by resolutions of its Board of Directors duly adopted by Unanimous Written Consent as of the 18th day of December, 2014 A.D., determined to and did merge into itself said Tropos Networks, Inc., which resolutions are in the following words to wit:

WHEREAS this corporation lawfully owns more than 90% of the outstanding stock of Tropos Networks, Inc., a corporation organized and existing under the laws of Delaware, and

WHEREAS this corporation desires to merge into itself the said Tropos Networks, Inc., and to be possessed of all the estate, property, rights, privileges and franchises of said corporation.

NOW, THEREFORE, it is hereby

RESOLVED, that this corporation merge into itself said Tropos Networks, Inc. and assumes all of its obligations, and

FURTHER RESOLVED, that the President, any Vice President, the Secretary and any Assistant Secretary ("Authorized Officer") of this corporation be and he or she is hereby authorized and directed to make and execute a certificate of ownership setting forth a copy of the resolution to merge said

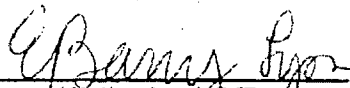
Tropos Networks, Inc. and assume its liabilities and obligations, and the date of adoption thereof, and to file the same in the office of the Secretary of State of Delaware, and
