**GRANT OF SECURITY INTEREST IN TRADEMARKS**

FOR VALUABLE CONSIDERATION, as of this 29 day of April, 2015, the receipt and adequacy of which is acknowledged, INTERSTATE WASTE SERVICES HOLDING CO., INC., a Delaware corporation ("Grantor"), grants to Brightwood Loan Services LLC, ("Brightwood"), as Administrative Agent and Collateral Agent for the Lenders under the Financing Agreement (as defined in the Security Agreement), a security interest and all of Grantor's right, title and interest in and to the following, whether existing now or later, or on which Grantor now has or later acquires an interest, and wherever the same may be located ("Trademark Collateral"):

1. All rights, title and interest (including rights acquired pursuant to a license or otherwise, but only to the extent permitted by the agreements governing such license or other use and without resulting in the abandonment, invalidation or unenforceability of any right, title or interest of Grantor therein) in and to the following trademarks (collectively, the "Trademarks") described on Exhibit A.
2. All proceeds, products, rents and profits of or from any and all the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not Brightwood is the loss payee), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise in respect of any of the foregoing Trademark Collateral. For these purposes, the term "Proceeds" includes whatever is received or receivable when any Trademark Collateral or other proceeds are sold, exchanged, collected or otherwise disposed of, whether such disposition is voluntary or involuntary.

Grantor has granted the security interest under this instrument pursuant to the terms of a Security Agreement, dated as of April 29, 2015 (as may be amended, restated and/or modified from time to time, the "Security Agreement"), made by Grantor and other parties thereto, in favor of Brightwood for the purposes of security as provided in the Security Agreement. Grantor acknowledges and affirms that the rights, privileges and remedies of Brightwood with respect to the security interest in the Trademark Collateral granted in this instrument are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated in this instrument by this reference.


