Trade Mark
Deed of Assignment

DEED dated April 23, 2015

BETWEEN: Pannard Management Pty Ltd

("the Assignor")

AND

Switzerland

("the Assignee")

BACKGROUND:

- A. The Assignor is the Applicant of US Trade Mark Application No. 86, 113276, the details of which are attached under Schedule A ("the Trade Mark").
- B. The Assignor has agreed with the Assignee to transfer the Trade Mark to the Assignee, for all the goods and services outlined in Schedule A.

AGREED TERMS:

Assignment

1. The Assignor hereby assigns, transfers and sets over to the Assignee all the Assignor's rights, title and interests in and to the Trade Mark, with the benefit of the said application therefor and of the registration to issue, with any goodwill which may subsist in the Trade Mark, but excluding the goodwill of its business associated therewith.
2. The Assignor agrees that, at the expense of the Assignee, it will execute all documents and take all steps as are necessary or convenient for effecting registration of the Trade Mark and for effecting recordal of this assignment.

3. The Assignor and the Assignee authorise the Registrar of Trade Marks in the United States to record the Assignee as the Applicant of the Trade Mark.

Consideration

4. The Assignor acknowledges receipt of good and valuable consideration from the Assignee.

Assignor's warranties and obligations

5. The Assignor warrants that:
 - (a) It has not assigned, licensed or otherwise encumbered in any manner, the Trade Mark; and
 - (b) neither the execution of this Deed nor the performance by it of its obligations will cause it to be in breach of any obligation to a third party.
6. The Assignor must not challenge or oppose, or assist or encourage any other person to challenge or oppose:
 - (a) the use of the Trade Mark by the Assignee (or by a licensee or the Assignee); or
 - (b) the validity of the registration of the Trade Mark.
7. The Assignor must provide to the Assignee such further assistance as is reasonably requested by the Assignee to:
 - (a) facilitate the recording of the Assignee as registered owner of the Trade Mark at the United States Patent and Trade Marks Office; and
 - (b) defend any non-use, cancellation or revocation action against the Trade Mark by a third party.

Terms binding on associated entities

8. Each party must use its best endeavors to ensure that it, and any companies or other businesses which it controls, or any company which is associated with it in any material respect, or any officer of that company, shall comply with all of the provisions of this Deed.

Governing Law

9. This Deed is governed by the laws of Australia.

10. Each party irrevocably and unconditionally submits to the exclusive jurisdiction of the courts of Australia.

Counterparts

11. This Deed may be executed in counterparts and those counterparts together make one instrument.






