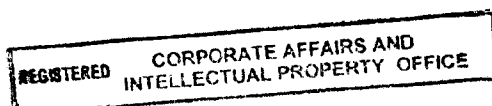

RESOLVED THAT:

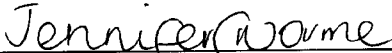

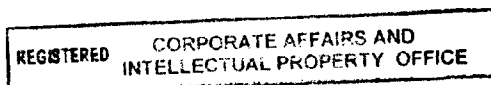
