## ASSET PURCHASE AGREEMENT

THIS ASSET PURCHASE AGREEMENT ("Agreement") is made and entered as of December 29, 2010 ("Effective Date"), by and between KENEXA TECHNOLOGY, INC., as purchaser ("Kenexa"), a Pennsylvania corporation, with offices at 650 East Swedesford Road, Wayne, Pennsylvania 19087, TALENTMINE LLC, as seller ("TalentMine"), a Nebraska limited liability company, with an address at 6101 Village Drive, Suite 101, Lincoln, Nebraska 68516 and Dr. Courtney R. ### ARTICLE ONE: PURCHASE OF ASSETS

1.1 Purchased Assets. For the consideration, in the manner and upon the terms and conditions hereinafter set forth, TalentMine agrees to sell, convey, transfer and assign to Kenexa and Kenexa agrees to accept and assume from TalentMine, as of the close of business on the Closing Date.

(a) All intangible assets, including trademark registrations and applications, copyrighted works, copyright registrations and applications, all patents, patent applications, inventions, trade secrets, know-how, current and former customer and prospect lists, designs and the like, and all licenses, tradenames, trademarks and service marks, permits and registrations legally transferable and other Intellectual Property (as hereinafter defined), all websites including talentmine.com, telephone numbers and telephone listings related to the Business, domain names, URL addresses; and the goodwill of the Business;

(e) All software, computer code (source code and object code), storage media, assessments, documentation, reports, studies, databases, TalentMine inventories, training materials associated with the TalentMine® System, as more specifically set forth on Schedule 1.1(e) attached hereto.
