**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of May 4, 2015 (this "Release"), is made by JPMorgan Chase Bank, N.A., as Administrative Agent (the "Agent"), in favor of Humana, Inc., successor in interest to Concentra Operating Corporation, (the "Grantor") as follows:

**WITNESSETH**

WHEREAS, pursuant to the Grant of Security Interest, dated as of August 13, 2003 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on September 16, 2003 at Reel/Frame No. 2825/0225, Concentra Operating Corporation granted JPMorgan Chase Bank a security interest in certain collateral described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Agent; and

WHEREAS, the Grantor has requested that the Agent release its security interest in all right, title and interest of the Agent in and to the Trademark Collateral.

NOW, THEREFORE, the Agent, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any and right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.

The Agent agrees to provide Grantor with any information and additional authorization and documentation necessary to effect the release of the Agent's security interest in the Trademark Collateral (without recourse, representation or warranty and at Grantor's sole cost and expense).
