**FULL RELEASE AND RECONVEYANCE OF INTELLECTUAL
PROPERTY SECURITY INTERESTS**

Reference is hereby made to that certain Intellectual Property Security Agreement dated September 15, 2003, as subsequently amended, restated, supplemented or otherwise modified (the "IP Security Agreement"), by and between **CONSOL ENERGY INC.**, a Delaware corporation ("Consol"), and **CITICORP NORTH AMERICA, INC.**, having a place of business at 388 Greenwich Street, New York, New York, 10013 ("Collateral Agent"). Unless otherwise defined herein, terms defined in the IP Security Agreement shall have the meanings given to them in the IP Security Agreement.

WHEREAS, execution of the IP Security Agreement was a condition precedent of Consol receiving advances under the September 16, 2002 364-Day Credit Agreement and the Three Year Credit Agreement (collectively, the "Senior Credit Facilities");

WHEREAS, by way of the IP Security Agreement, Consol granted Collateral Agent a security interest in certain intellectual property (hereinafter collectively, the "IP Collateral");

WHEREAS, Consol has now repaid all amounts due under the Senior Credit Facilities and all commitments under the Senior Credit Facilities are terminated;

NOW, THEREFORE, in consideration of the fulfillment of the covenants made by Consol under the Senior Credit Facilities and the IP Security Agreement, and having full authority to do so, the Collateral Agent hereby forever releases and discharges its interests in the IP Collateral and reconveys to Consol, to the extent of its interest therein, the IP Collateral, without recourse, representation or warranty of any kind, express or implied.

This Full Release and Reconveyance of IP Security Interests may be filed with the United States Patent & Trademark Office.

For the avoidance of doubt, this Full Release and Reconveyance of IP Security Interests shall apply only to the IP Collateral identified on the attached Exhibit A and the IP Security Interests related thereto.

This Full Release and Reconveyance of IP Security Interests shall be governed by and construed in accordance with the laws of the State of Pennsylvania without regard to any principles of conflicts of law that would cause the laws of another jurisdiction to apply.
