Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and similar officials of any State or in any applicable jurisdictions within and outside the United States to record the transfer of the Trademark Properties set forth on Exhibit A to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees, on request of Assignee, and at Assignee's expense, to execute any further documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademark Properties.

This Assignment of Trademarks may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each

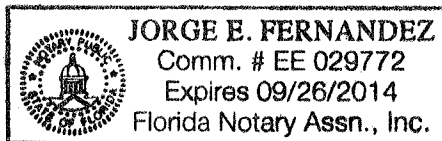

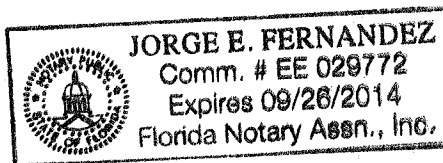
