TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, Assignee desires to acquire all of Assignor's right, title and interest in and to the Trademarks, along with the goodwill pertaining thereto and associated therewith, as the successor in interest to that portion of Assignor's business associated with the Trademarks.

NOW, THEREFORE, in consideration of the foregoing and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


1. Assignment of Trademarks. Assignor hereby assigns to Assignee, and Assignee, as the successor in interest to that portion of Assignor's business associated with the Trademarks, hereby accepts the assignment of, all of Assignor's right, title and interest in and to the Trademarks and the goodwill pertaining thereto and associated therewith, and including without limitation the right to sue for relief and recover damages for past, present or future infringement or dilution thereof and for the use and benefit of its successors, assigns and legal representative.

2. Counterparts. This Agreement may be executed in two counterparts, all of which shall be considered one and the same instrument and shall become effective when one or more counterparts have been signed by each of the parties and delivered to the other party. This Agreement may be executed by facsimile signature and a facsimile signature shall constitute an original for all purposes.


