RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT is made as of May 15, 2015, by BANK OF AMERICA, NATIONAL ASSOCIATION, formerly known as First Valley Bank, as secured party ("Secured Party"), for the benefit of THE AMERICAN BELT COMPANY, formerly known as Reborn Products Co., Inc., a Pennsylvania corporation, as debtor ("Debtor").

RECITALS

Debtor is the owner of certain United States Trademark Registrations, as set forth on Schedule A attached hereto and made a part hereof (collectively, the "Trademarks").

On or about May 20, 1993, Debtor granted to Secured Party a security interest in and to certain collateral, including, without limitation, the Trademarks, pursuant to the terms of a Security Agreement, dated as of May 20, 1993 (the "Security Agreement").

On or about July 12, 1996, Secured Party changed its name from First Valley Bank to Summit Bank.

On or about March 1, 2001, Secured Party was merged into and subsequently operated as part of Fleet National Bank.

On or about June 13, 2005, Secured Party was merged into and subsequently operated as part of Bank of America, National Association.

As of the date hereof, the entire indebtedness of Debtor to Secured Party, to the extent secured by the Security Agreement, has been satisfied by or on behalf of Debtor to Secured Party. Therefore, Debtor has requested that Secured Party: (a) release Debtor from the obligations set forth in the Security Agreement, and (b) release the Trademarks from the lien of the Security Agreement.

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party does hereby: (a) fully release Debtor, its successors and assigns, from any and all obligations set forth in the Security Agreement, and (b) fully release and discharge the Trademarks from the effect and operation of the Security Agreement.

IN WITNESS WHEREOF, the undersigned has caused this Release of Security Agreement to be executed and made effective as of the date first above written.


