**CERTIFICATE OF AMENDMENT
OF CERTIFICATE OF INCORPORATION
OF
SILI GOODNESS, INC.**

The undersigned corporation, organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

1. That Kristin Ahmer is the duly elected and acting President of Sili Goodness, Inc., a Delaware corporation (the "Corporation").

2. That Article I. of the Certificate of Incorporation of the Corporation is amended to read in full as follows:

"I.

The name of the corporation is Squeezing the Goodness, Inc. (the "Corporation")."

3. That Article IV. of the Certificate of Incorporation is amended to read in full as follows:

"IV.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 500,000, of which all 500,000 shares shall have a par value of \$0.0001 per share, and be designated as "Common Stock." The Common Stock shall be divided into two series to be designated "Series A Common Stock" and "Series B Common Stock," respectively. The number of shares of Series A Common Stock the Corporation is authorized to issue is 400,000 and the number of shares of Series B Common Stock the Corporation is authorized to issue is 100,000."

4. That this Certificate of Amendment of Certificate of Incorporation has been duly approved by the Board of Directors of the Corporation.

5. That this Certificate of Amendment of Certificate of Incorporation has been duly approved by the stockholders of the Corporation by written consent in lieu of a meeting in accordance with the applicable provisions of Section 228 and Section 242 of the General Corporation Law of the State of Delaware.
