FIRST: The name and jurisdiction of formation or organization and domicile of each of the constituent entities is: ZOETIS WHC 2 LLC ("WHC 2"), which was organized as and is a Delaware limited liability company, and ZOETIS SERVICES LLC, which was organized as and is a Delaware limited liability company (the "Company").

FIFTH: This Certificate of Merger shall be effective as of April 26, 2015.
