TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Trademark Agreement") is entered into as of May 1, 2015, (the "Effective Date") by and between The Trustees of The Coppola Family Trust, a California trust, with the address of 916 Kearny Street, San Francisco, California 94133 ("Assignor") and American Zoetrope, a California corporation, with its principal business offices at 916 Kearny Street, San Francisco, California 94133 ("Assignee").

WHEREAS, Assignor is composed of Francis Ford Coppola, a U.S. citizen, and Eleanor Coppola, a U.S. citizen, as Trustees;

WHEREAS, Assignor owns all right, title and interest in and to the trademarks listed in the attached Exhibit A, all registrations pertaining thereto and all common law rights associated therewith, together with all goodwill arising from the use of and symbolization by said trademarks (referred to herein as the "Trademarks"); and

WHEREAS, Assignor desires to transfer all right, title and interest in and to the Trademarks to Assignee.

NOW, THEREFORE, in consideration of their mutual interests and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:


1. Assignor hereby assigns, transfers, sells, conveys, and delivers to Assignee, its successors and assigns, all right, title and interest in and to the Trademarks throughout the world, including without limitation the goodwill of the business appurtenant thereto and which is symbolized thereby, that portion of the business to which the Trademarks pertain, including the right to license others under the Trademarks and the right to renew any trademark registrations which shall issue from the applications included in the Trademarks, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives, to be used as fully and entirely as said rights would have been held and enjoyed by Assignor had this assignment and sale not been made.
2. Assignor authorizes Assignee to record this agreement in the United States Patent & Trademark Office and in similar government offices throughout the world.
3. This Trademark Agreement shall be construed, performed and enforced in accordance with, and governed by, the laws of the State of California, without giving effect to the principles of conflicts of law.


