This Deed is made on APRIL 17 2015

**PARTIES:**

- (1) Roger Buoy (an individual) whose address is The Old Vicarage, Harford Square, Chew Manga, Somerset, BS40 8RA, United Kingdom ('RB').
- (2) The Somerset Toiletry Company Limited (Company Number 03748299) whose registered office is at Unit 15 Clutton Hill Farm Estate, Clutton, Bristol, BS39 5QQ, United Kingdom ('TSTC').

**BACKGROUND:**

- A RB is the owner of the trade marks listed in the Schedule ('Trade Marks').
- B RB has agreed to assign all his rights in and to the Trade Marks to TSTC in accordance with the provisions of this Deed.

**PROVISIONS:**

**1. Assignment**

RB assigns to TSTC the Trade Marks and all and any statutory and common law rights in and to the Trade Marks including any rights of priority, powers, liberties and immunities attaching to the Trade Marks and all the goodwill attaching to the Trade Marks.

**2. Proceedings**

TSTC will have the right to bring proceedings against any third party in respect of the Trade Marks (including, without limitation, proceedings against any third party for past infringement of the Trade Marks or for passing off or for otherwise infringing the rights of RB in the Trade Marks).

3. Further Assurance

RB shall on request by TSTC in writing and at TSTC's expense do and execute or arrange for the doing and executing of, each necessary act, document and thing reasonably within his power to implement this Assignment.


4. Law and Jurisdiction




