RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("**Trademark Release**") is made and effective as of May 1, 2015, and granted by WILMINGTON TRUST COMPANY (the "**Collateral Agent**"), a Delaware trust company (formerly a Delaware corporation), located at 1100 N. Market Street, Wilmington, Delaware, as collateral agent for the secured parties under the Pledge and Security Agreement dated as of June 30, 2009 (the "**Secured Parties**"), in favor of UNITED SUBCONTRACTORS, INC., a Utah corporation (the "**Grantor**").

WHEREAS, pursuant to a certain Trademark Security Agreement, dated as of June 30, 2009 (the "**Trademark Security Agreement**"), by and between Wilmington Trust Company, as Collateral Agent and the Grantor, the Grantor granted a security interest in certain Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks listed in the attached Schedule 1, to the Collateral Agent for the benefit of the Secured Parties.

WHEREAS, the Grantor executed and delivered the Trademark Security Agreement to the Collateral Agent;

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office at 004046/0173 on August 18, 2009; and

WHEREAS, the Grantor has requested that the Collateral Agent enter into this Trademark Release in order to accomplish and evidence the release and reassignment of any and all right, title and interest the Collateral Agent and the Secured Parties may have in the Trademark Collateral pursuant to the Trademark Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent and the Grantor hereby state as follows:

1. Release of Security Interest. The Collateral Agent, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, terminates, releases and discharges its security interest in and to the Trademark Collateral, and all other right, title, and interest in and to the Trademark Collateral and reassigns to the Grantor any and all such right, title and interest that it may have in the Trademark Collateral. The Collateral Agent hereby authorizes the Grantor, or the Grantor's authorized representative, to record this Trademark Release with the United States Patent and Trademark Office.
2. Further Assurances. The Collateral Agent agrees (at the cost of the Grantor) to execute, acknowledge, procure and deliver to Grantor any and all further documents or instruments and do any and all further acts which the Grantor (or its respective agents, designees or assignees) reasonably request in order to confirm, effectuate or record this Trademark


Release and the Grantor's (or its assignees') right, title and interest in and to the Trademark Collateral.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Trademark Release and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
4. Counterparts. This Trademark Release may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Trademark Release by telecopy or other electronic means shall be effective as delivery of a manually executed counterpart of this Trademark Release.


