**TERM LOAN TRADEMARK SECURITY RELEASE**

THIS TERM LOAN TRADEMARK SECURITY RELEASE (this “Release”), made as of May 12, 2015 by ROYAL BANK OF CANADA, in its capacity as collateral agent (in such capacity, the “Collateral Agent”) under the Security Agreement (as defined below). Capitalized terms used and not otherwise defined herein shall have the meaning assigned to such term in the Security Agreement.

**WITNESSETH:**

WHEREAS, pursuant to (i) that certain Trademark Security Agreement dated as of December 13, 2013 (the “Trademark Security Agreement”) by Norcraft Canada Corporation, a Nova Scotia unlimited liability company (the “Pledgor”) in favor of the Collateral Agent and (ii) that certain Canadian Security Agreement dated as of December 13, 2013 (the “Security Agreement”) by and among the Pledgor, the guarantors listed on the signature pages thereto and the Collateral Agent, the Pledgor has pledged and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title, and interest in, to, and under the Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on December 13, 2013 at Reel 5176 Frame 0811; and

WHEREAS, at the request of the Pledgor, the Collateral Agent has agreed to release its security interest in the Trademark Collateral (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases and discharges (i) the Trademark Security Agreement and (ii) its lien on and security interest in and to all of Pledgor’s right, title and interest in, to and under all of the following Collateral (collectively, the “Trademark Collateral”):

- (a) registered Trademarks and applications therefor of the Pledgor listed on Schedule I attached hereto;
- (b) all Goodwill associated with such Trademarks; and
- (c) all Proceeds of any and all of the foregoing (other than Excluded Property).

The release set forth above is without recourse, representation, warranty (express or implied) or undertaking by the Collateral Agent to the Pledgor.

This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.


