RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of May 12, 2015 by BANK OF AMERICA, N.A. (the "Lender"), in favor of CREDIBILITY CORP. (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

WHEREAS, the Grantor entered into that certain Security Agreement dated as of October 23, 2012, (as the same may be amended, restated, extended, supplemented or otherwise modified from time to time, the "Security Agreement"), pursuant to which Grantor granted to the Lender a continuing security interest in, and a right to set off against, any and all right, title and interest of Grantor in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing, including the United States Trademarks identified on Schedule 1 hereto (the "Trademark Collateral");

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to Lender the (1) Notice of Grant of Security Interest in Trademarks, dated as of October 23, 2012, which was recorded at the United States Patent and Trademark Office ("USPTO") on February 25, 2015 at Reel 5466 Frame 0261; (2) Notice of Grant of Security Interest in Trademarks, dated as of October 23, 2012, which was recorded at the USPTO on June 4, 2014 at Reel 5296 Frame 0152; (3) Notice of Grant of Security Interest in Trademarks, dated as of October 23, 2012, which was recorded at the USPTO on September 24, 2013 at Reel 5116 Frame 0807 and (4) Notice of Grant of Security Interest in Trademarks, dated as of October 23, 2012, which was recorded at the USPTO on October 24, 2012 at Reel 4887 Frame 0788; and

WHEREAS, the Lender desires to terminate and release its security interest in and lien on the Grantor's right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender, without representation, warranty, or recourse, hereby (a) terminates, discharges and releases its security interest in and lien on the Grantor's right, title and interest in, to and under the Trademark Collateral and (b) authorizes and requests that the Commissioner of Trademarks at the USPTO and any other applicable government officer record this Release at Grantor's expense.

This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to the conflicts of law principles that would require the application of the laws of another jurisdiction.
