REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This REASSIGNMENT AND RELEASE OF SECURITY INTEREST (this "Release") is entered into as of May 13, 2015, by COMERICA BANK, a Texas banking association ("Assignor") in favor of CREATINGWILL.COM, LLC, a Delaware limited liability company ("Assignee") with its chief executive office located at 101 N Brand Blvd., Suite 1100, Glendale, CA 91023.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases its security interest in the Intellectual Property and reassigns to Assignee, without representation, warranty, recourse or undertaking, all of Assignor's interest in the Intellectual Property.

Assignor further authorizes and requests that the Commissioners of Patents and Trademarks record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of California, without giving effect to its principles regarding conflicts of law.
