Assignor further authorizes and requests that the Commissioners of Patents and Trademarks and the Register of Copyrights record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of California, without giving effect to its principles regarding conflicts of law.
