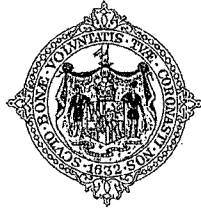

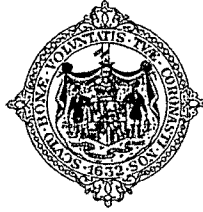

Pursuant to Section 3-903 of the Maryland General Corporation Law, East Coast Fresh Cuts, Inc., a Maryland corporation (the "Corporation"), submits the following Articles of Conversion:

1. The Corporation filed its original Articles of Incorporation with the Department of Assessments and Taxation on January 2, 2003.


