TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of May 14, 2015, and made by GENERAL ELECTRIC CAPITAL CORPORATION, in its capacity as Collateral Agent for certain lenders and the letter of credit issuers ("Grantee") to SPECTRUM PLASTICS GROUP, INC. ("Grantor").

WHEREAS, Grantor entered into a Counterpart Agreement, dated as of September 3, 2013, upon the execution and delivery of which Grantor became party to that certain Pledge and Security Agreement, dated as of July 31, 2012 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time), among the Grantor and certain other grantors from time to time party thereto and the Grantee (the "Collateral Agreement") pursuant to which a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 9, 2012 made by Grantor in favor of Grantee (the "Security Agreement"), Grantor granted a security interest specifically in the Trademark Collateral to the Grantee for purposes of recording such grant;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on September 3, 2013, at Reel 5102 and Frame 0790; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademark Collateral" as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates releases and discharges its security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral.
