IV.

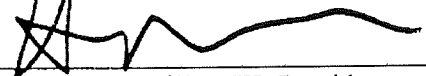
The Amendment was adopted by the unanimous written consent of all Directors on August 1, 2000. Shareholder approval of said Amendment was not required.

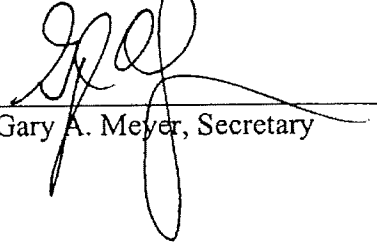
V.
