
**TRADEMARK ASSIGNMENT**

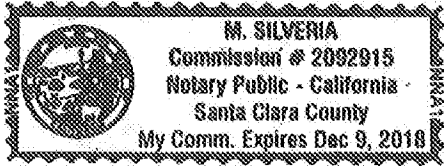
