**BILL OF SALE AND  
ASSIGNMENT AND ASSUMPTION AGREEMENT**

THIS BILL OF SALE AND ASSIGNMENT AND ASSUMPTION AGREEMENT (the "Bill of Sale and Assignment and Assumption Agreement") is made and entered into effective as of the 1st day of March, 2012, between TRILOGY GLASS & PACKAGING, INC., a California corporation ("Assignor"), and TRICORBRAUN INC., a Missouri corporation ("TricorBraun").

WHEREAS, Assignor owns certain assets that it desires to transfer to TricorBraun; and

WHEREAS, TricorBraun desires to obtain certain assets of Assignor.

NOW, THEREFORE, the parties hereby agree as follows:

1. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby grants, sells, conveys, delivers, assigns, and transfers to TricorBraun all of Assignor's right, title and interest in and to all of the assets of Assignor (including personal property), except with respect to those items set forth on Exhibit A.


2. TricorBraun hereby agrees to accept title to and ownership of the assets conveyed pursuant to paragraph 1 above.

3. TricorBraun also hereby agrees to assume any and all liabilities known to be existing as of the effective date of this Bill of Sale and Assignment and Assumption Agreement and which are reflected in Assignor's balance sheet dated as of close of business on February 29, 2012, except for liabilities with respect to those items set forth on Exhibit A attached hereto. For the sake of clarity, TricorBraun shall not be deemed to have accepted the transfer of, or assume any liabilities with respect to, the agreements referenced in Items 1, 2, 3 or 4 on Exhibit A.


