**PARTIAL RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This PARTIAL RELEASE, dated as of May 14, 2015 (this "Partial Release"), is made by BROADWAY CAPITAL CORP., LLC, ("Secured Party"), in favor of VOICE MEDIA GROUP, INC. ("Grantor") as follows:

WITNESSETH

WHEREAS, pursuant to the Trademark Security Agreement, dated January 17, 2013 (the "Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office as identified on the attached Schedule A, the Grantor granted the Secured Party a security interest in certain collateral pledged by the Grantor described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Grantor has requested that the Secured Party release its security interest in all right, title and interest of the Secured Party in and to the Trademark Collateral but only the Trademark Collateral described in Schedule A and no other collateral described in the Trademark Security Agreement.

NOW, THEREFORE, the Secured Party, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any and right, title and interest of the Secured Party in the Trademark Collateral shall hereby terminate, cease and become void; however all other collateral described in the Trademark Security Agreement shall remain subject to the Trademark Security Agreement and is not released pursuant to this Partial Release.


Secured Party agrees to provide Grantor with any information and additional authorization and documentation necessary to effect the release of Secured Party's security interest in the Trademark Collateral (without recourse, representation or warranty and at Grantor's sole cost and expense) but only as to the Trademark Collateral and not as to any other collateral described in the Trademark Security Agreement.

Except as specifically described in this Partial Release, all other collateral described in the Trademark Security Agreement and recorded with the U.S. Patent and Trademark Office remains subject to the security interests granted by Grantor in favor of Secured Party and is not released.
