1. DEFINITIONS

All capitalized terms used in this General Security Agreement (the "Agreement") and in any Schedules attached hereto shall, except where defined herein, be interpreted pursuant to their respective meanings when used in the *Personal Property Security Act* of Alberta (the "Act"), as in force at the date of this Agreement, which Act including amendments thereto and any Act substituted therefor and amendments thereto is herein defined as the "PPSA".

2. SECURITY

2.1 Grant of Security Interest in IP Collateral

As continuing security for the payment and performance of all debts, liabilities and obligations of the Debtor to the Secured Party howsoever arising (past, present, and future, absolute and contingent) (collectively, the "Indebtedness"), the Debtor grants, mortgages, pledges and hypothecates to and in favour of the Secured Party a security interest in all of the following property (collectively, the "IP Collateral"), whether now owned or hereafter acquired or existing:


- (a) All right, title and interest of the Debtor in and to the trade-marks listed on Schedule "A" attached hereto, and all variations, reissues, extensions or renewals thereof, including without limitation, all Canadian and United States trade-mark registrations and pending Canadian and United States trade-mark applications;
- (b) All right, title and interest of the Debtor in and to any unregistered trade-marks and trade names used in the business of the Debtor, including, without limitation, those unregistered trade-marks and trade names listed in the Schedules "B" and "C" attached hereto;
- (c) All right, title and interest of the Debtor in and to any trade-marks confusingly similar to any of the foregoing trade-marks and all goodwill in, to or associated to such trade names;
