## TRADEMARK ASSIGNMENT


ASSIGNOR hereby covenants and agrees to and with ASSIGNEE, that, as of the effective date of this Assignment, ASSIGNOR was the sole and lawful owner of the entire right, title and interest in and to the above mentioned Marks, that the same was unencumbered, and that ASSIGNOR had good and full right and lawful authority to sell and convey the same in the manner herein set forth. ASSIGNOR hereby further covenants that no assignment, sale agreement or encumbrance will be made or entered into that would conflict with this Assignment.

ASSIGNOR further covenants for itself, its successors, assigns and legal representatives to provide to ASSIGNEE promptly upon the request of ASSIGNEE and at the expense of ASSIGNEE all pertinent facts and documents relating to said Marks as may be known and accessible to ASSIGNOR and promptly to execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments, or affidavits and to perform any other lawful acts that may be deemed necessary to apply for, obtain, maintain, issue or enforce said Marks which may be necessary or desirable to carry out the purposes thereof.

IN WITNESS WHEREOF, the ASSIGNEE, by executing and delivering this Agreement as of the date first written above, has agreed, and upon acceptance of such subscription the ASSIGNOR has agreed, to be bound by the terms and conditions of this Agreement effective as of the Closing Date.

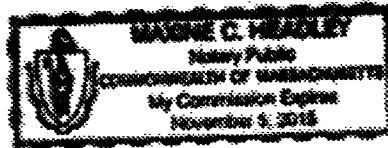
