Assignor authorizes the Commissioner for Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registrations and/or applications for registration and/or issue any and all certificates of registration of the Trademarks set forth on Schedule 1 to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademarks or the rights conveyed herein.

Assignor hereby agrees, without further consideration and without expense, to sign all lawful papers and to perform all other lawful acts which Assignee may request of it to make this Assignment Nunc Pro Tunc fully effective.
