- Any application from which any of the foregoing claims priority; and
- Any past or present right or cause of action arising with respect to any of the foregoing, including any right to sue for trademark infringement, and any derivative right thereof,

(hereinafter collectively "Trademark Rights").

FURTHERMORE,

Assignor hereby acknowledges that any and all Trademark Rights related to any Trademark already may have been under obligations of assignment already to Assignee and in fact may have already been assigned to Assignee, and that this "Assignment of Trademark Rights" (hereinafter "Assignment") is being duly executed for at least the purposes of public recordation with the USPTO of Assignee's rights, title, and interests in the Trademark Rights.

Assignor hereby consents and agrees that a copy of this Assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file, or like document that may be required in any particular country for any purpose and, more particularly, in proof of the right of Assignee to claim the aforesaid benefit of the right of priority and the right to file for patent.

Assignor covenants and agrees that this Assignment and all the terms thereof shall inure to the benefit of the successors, assigns, legal representatives, and nominees of Assignee, without further written or oral authorization from Assignor.

Assignor further hereby represents and warrants that Assignor is an original inventor of the Trademark; and Assignor has reviewed and understood the contents of the Patent Property.

Finally, Assignor hereby authorizes and requests the Director of the United States Patent & Trademark Office to issue any patent included within the Trademark Rights to Assignee.

This Assignment is governed by and shall be construed in accordance with the laws of North Carolina.
