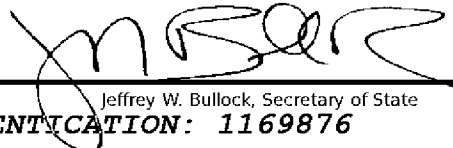

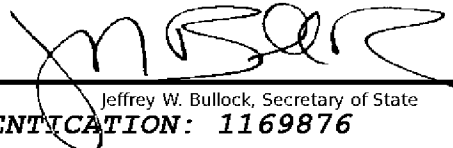

FIRST. Name. The name of the limited liability company is TriMech Services, LLC (the "Company").
