ARTICLE I

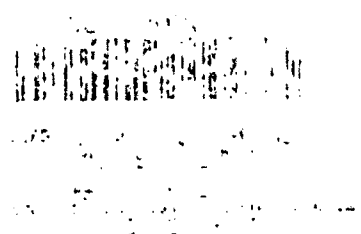
Entity Name and Type
