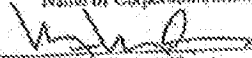

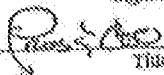

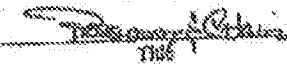

AGREEMENT AND PLAN OF MERGER

No provisions of the Articles of Incorporation of the Surviving Corporation are amended or modified subsequent to the effective date and time of the plan of merger.

The undersigned, desiring to effect a merger pursuant to Title 8, Section 256 of the Delaware General Corporation Law, hereby certifies as follows:

1. The name of the surviving corporation is ACTS Retirement-Life Communities, Inc., a Pennsylvania nonprofit corporation (the "Surviving Entity"). The jurisdiction in which the Surviving Entity was formed is the Commonwealth of Pennsylvania.
2. The name of the corporation being merged with and into the Surviving Entity is Peninsula United Methodist Homes, Inc., a Delaware nonprofit corporation (the "Merging Entity"). The jurisdiction in which the Merging Entity was formed is the State of Delaware.
3. The Agreement and Plan of Merger (the "Agreement of Merger") has been approved, adopted, certified, executed and acknowledged by the Surviving Entity and the Merging Entity in accordance with Title 8, Section 256 of the Delaware General Corporation Law.
4. The merger shall be effective on July 1, 2014 at 12:01 a.m. (the "Effective Time").
5. The name of the Surviving Corporation shall be "ACTS Retirement-Life Communities, Inc."
6. The Articles of Incorporation of the Surviving Corporation will be its Articles of Incorporation.
7. The executed Agreement of Merger is on file at 375 Morris Road, West Point, PA 19486, which is the principal place of business of the Surviving Entity.
8. A copy of the Agreement of Merger will be furnished by the Surviving Entity on request, without cost, to any member of the Surviving Entity or any member of any other business entity which is to merge with and into the Surviving Entity.
9. The Surviving Corporation agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of the Surviving Corporation arising from this merger and shall irrevocably appoints the Secretary of State of Delaware as its agent to accept service of process in any such suit or proceeding. The Secretary of State of Delaware may mail any such process to the Surviving Corporation at PO Box 90, West Point, PA 19486, Attn: General Counsel.
